On 14 February 2020, the Company announced an acquisition of 20.2% equity interests in Red Power Developments Limited (the “**Acquisition**”). The consideration is payable by the Company via issuing 33,658,000 new shares of the Company with the nominal value of HK\$0.1 per share (the “**Consideration Shares**”). On 1 September 2020, the Company announced the completion of the Acquisition and the issuance of the Consideration Shares.
